### **Surveillance of certification bodies under the Canadian Organic Regime**

The listed certification bodies are under the surveillance of the International Organic Accreditation Service under its programme for assessment of compliance against the requirements set down in:

- Organic Products Regulations, 2009

The certification bodies are required to operate an organic certification system in compliance with the following documents:

- ISO/IEC Guide 65: 1996 General requirements for bodies operating product certification systems.
- Part C of the Quality Management Systems Manual published by the Canadian Food Inspection Agency (CFIA)<sup>1</sup>
- Canada Organic Production Systems General Principles and Management Standard - CAN/CGSB.32.310 as amended<sup>2</sup>
- Organic Production Systems Permitted List - CAN/CGSB.32.311 as amended<sup>3</sup>

The IOAS recommends accreditation to the Canadian Organic Office (COO) which in turn will make the official decision on accreditation. For the list of accredited organisations please visit the COO web site at <http://www.inspection.gc.ca/english/fssa/orgbio/cbliste.shtml>. The date on which the IOAS sent a letter of recommendation to the COO is indicated. If no date is indicated the assessment is in process.

The possible categories of certification are: crop production, livestock production, grain production, maple syrup production, specialized production, food processing, subsequent packaging, brokerage.

The countries of operation indicates the countries where the organisation has clients certified against the Canadian standards.

The Canadian Organic Regime (COR) came into force on 30 June 2009.
